The 3rd workshop of the <u>Swiss Network on Public Economics</u> will be organised by <u>KOF</u> Swiss Economic Institute at ETH Zurich and the <u>Chair of Public Economics</u> at the University of Fribourg on Friday, <u>18 March 2022</u> (ca. 8.45 a.m. – 6.45 p.m.) at ETH Zurich. Format of the Workshop

The workshop will consist of three parts with the Chatham House Rule applying throughout the workshop. In the first part, participants from academia and the public sector will present their **planned and ongoing research** to gather feedback from colleagues.

The second part consists of two applied economic policy sessions organized by the Federal Department of Finance on "**The OECD/G20-Global Minimum Taxation for Multinational Enterprises: Policy Options for Switzerland**" and by the Federal Office for Statistics and the Federal Social Insurance Office on "**Die Steuerdatenerhebung als Pilotprojekt des Programms Nationale Datenbewirtschaftung (NaDB)**".

The plenary discussion in the third part is on "Mindestlöhne in der Schweiz":

- Introduction by Ursina Jud (SECO, State Secretariat for Economic Affairs),
- Keynote (in English) by Attila Lindner (University College London), and
- Presentation by Conny Wunsch (University of Basel).

Goal of the Network

The goal of the network is to connect researchers working on topics related to Swiss public economics (including public finance and public policy) and/or an interest in Swiss data. The network aims to strengthen the ties between academics and practitioners at universities, public administration, the Swiss National Bank and private institutions. Actors of the civil society as well as the media are welcome to join our network and its activities - please note that all discussions are held under the Chatham House Rule.
