Topic:

The present workshop is organized by Samantha Besson and Jean d'Aspremont with the sponsorship of the Swiss National Foundation for Scientific Research (SNF).

It is meant to perpetuate the discussion that has been initiated by the publication of the Oxford Handbook of the Sources of International Law (Besson and d'Aspremont (eds), OUP, 2017) and to add new voices to the debate by addressing outstanding theoretical, epistemological and empirical questions pertaining to the sources of international law.

Format and output:

The workshop is organized as a roundtable structured around four specific themes. Each of these themes will be introduced by one participant.

Participants are not expected to make any formal presentation and there will be no panels properly speaking. However, participants are strongly invited to prepare by reading the provided materials and reflect upon the four substantive themes indicated below with a view to contributing actively to the discussion.

We hope that, after the workshop, some of the participants will be willing to turn their substantive contribution and thoughts into an *ESIL Reflection* (publication of the European Society of International Law).
