#### Visa application

To study in Cambodia a Business Visa is required. It cost 40\$ and can be purchased at the arrival, at the airport. Its validity is one month. Then the visa must be renewed for a period of 6 months (150\$), or 3 months (75\$) or 1 month (45\$)

#### Accommodation

The renting fees vary according to the chosen type of accommodation.

For a colocation, one must count 150-200\$/month for one person. For accommodation on its own one must count 200-300\$/month.

#### Language Level

The programme takes place in English. A good level, speaking and understanding, is required. An interview via Skype with the candidates enables to test the English level.

#### **Compulsory vaccinations**

- The regular vaccinations : Diphtheria, Tetanus, Poliomyelitis, Pertussis, and Hepatitis B
- Hepatitis A
- Typhoïd

#### Currency

The American dollar is used everywhere, and the local currency, the *riel*, is used as small change.

### **Application Procedure**

#### Conditions to apply:

The programme is open to the Master of Law students who are in their final year of study. The participating students from Fribourg shall meet one of the following English proficiency requirements:

- TOEFL: paper-based 595 / internet-based 97
- IELTS 7.0
- Other equivalent qualifications

#### **Application:**

The application file, in English, is composed of:

- Pre-inscription form

- Curriculum Vitae with picture
- Statement of interest written in English
- Provisional list of the courses you wish to follow

- The application file must be sent to the Faculty of Law's Erasmus and International Relations Office, MIS 4060, Avenue de l'Europe 20, 1700 Fribourg.
- Application deadline: April 25, 2016

Places: 2 places of one year.

*Selection*: At Fribourg University, a first selection will be made by the convention co-ordinator. A definitive selection will be made by RULE.

*Tuition fees*: The regular tuition fees for this programme are 3'000\$. However, thank to the collaboration of the professors from Fribourg, students from Fribourg may benefit from a substantial reduction. For the academic year 2016/2017, the tuition fees for the Fribourg students are: 600\$.

#### Recognition

The recognition principles decreed by the Equivalence Committee of the Faculty of Law apply for the recognition of the exams passed during the study period at RULE. We however draw your attention on the fact that there is no double-validation of the exams and credits.
